## PRIVACY POLICY for e-mails

We process the following **categories of personal data** about you (personal data which are not considered sensitive), insofar as they have been made available to us or provided by you:

In the event of a contract being concluded, all data will be **stored** in accordance with the statutory retention requirements for period of 7 (seven) years. Thereafter, the data is automatically deleted. In case that no contractual relationship exists or no suitable position can be offered, your data will automatically be deleted after 72 months. Unless a deletion is demanded at an earlier occasion where there is no contractual relationship. Then a deletion is accomplished within 30 days after the request was made.
